#### **Methods and materials for containment and cleaning up**

**Spill** Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). ### **Precautions for safe handling**

Avoid release to the environment. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use.
